_____ **Activity Area Coordinator** *Although staff members have opportunities to lead all different types of activities, there is often a coordinator of certain activity areas to help organize supplies and materials and provide guidance to other staff members who lead these type of activities. Excellent organizational skills are must for coordinators. Several of these activity areas are listed below.*

- _____ Nature/Environmental Education

_____ **Lifeguard** *Guards during open swim activities and canoeing activities. Conducts swim tests as needed. May instruct swim lessons or supervise waterfront staff if qualified.*

_____ **Canoe Instructor** *Teaches introductory canoe lessons on the pond to small groups. Creatively plans instruction to utilize full two hour instruction period, taking into account small size of pond and interest level of campers.*

_____ **First Aid Liaison/Health Coordinator** *Serves as the primary first aider during all-camp activities. May dispense medications to campers.*

_____ **Lead Cook** *2-3 counselors and/or helpers work together to prepare each meal—cooking responsibilities are rotated throughout the staff. Lead cooks serve in a more directive capacity by having the opportunity to cook more frequently and direct the preparation and outcome of the meal including guiding other cooks during preparation.*

_____ **Woodworking Instructor** *Oversees woodworking shop by teaching woodworking skills and use of equipment, creating a progressive program for campers of multiple skill levels. Must be knowledgeable and able to care for and utilize hand tools.*

_____ **Archery Instructor** *Instructs archery program, teaching proper use and care of recurve bows and equipment.*

_____ **Morning Meeting Facilitator** *Plans and facilitates the daily Morning Meeting, a quiet, reflective time amidst nature which includes some singing and is sometimes guided and/or includes sharing/reflection topics. Experience with Quaker worship/practice helpful.*

_____ **Evening Games Facilitator** *Each evening all camp residents join together for a game or activity meant for fun and community building. Activities are non-competitive and should help the group develop over the duration of a session. Ideally the facilitator should be trained in group process and have extensive knowledge of team and trust building activities for large groups.*

_____ **Evening Singing Facilitator** *Plans and facilitates the evening singing period. Ideally facilitators are comfortable singing aloud in groups, have musical skill, and can inspire and unify campers and staff with varied musical backgrounds through music. Ability to play guitar or musical instruments is always helpful.*
